I hereby confirm my reservation for the Revised Carthusian Andalusian Black Stallion

Costalero XV Codigo # 190101002433480

1. A \$500 non returnable booking fee per mare must be returned with this signed contract
2. The stallion owner assumes responsibility only to deliver live semen in viable condition at time of delivery to mare owner.
3. Mare owner is responsible for the payment of all veterinarian charges necessary to collect stallion and inseminate the mare. Mare owner also pays shipping fees and container rentals when applied.
4. When semen is being shipped Majestic Andalusians DM is not responsible for care of the semen from the time it leaves, mare owner will take responsibility from time of shipment.
5. In the event that a live foal (one that stands and nurses) does not result, the mare or a suitable replacement mare may be returned for breeding during the same year as the foal was to be born, free of any additional stud fees. Mare owner pays collection and shipping costs etc.
6. It is agreed as follows: A breeding fee of \$2,250 Purebreds\$1,500 All Others. This includes the booking fee of \$500 in Section 1. This must be paid in full before a mare is inseminated or semen is delivered.
7. This semen is not assignable or transferable by either party. Semen must be used for the below referenced mare **all shipping fee and veterinary fees of semen and mare insemination are to be arranged between mare owner and not the responsibility of stallion owner.**
8. Mare owner assumes the risk of illness, injury or death of mare. Mare owner shall provide his or her insurance for such risk.
9. Mare owners will give stallion owner / stud farm, sufficient notice, at least 3 to 4 days or more if possible. This time is to make arrangements to take the stallion for collection or if collected at the farm we need to coordinate the vet's visit with the time of collection. If you do not meet this requirement it may not be possible to make last moment arrangements.
10. Any question arising under the terms of this contract shall be constructed and enforced under the State of Texas.

11. If the above terms are acceptable to you. Please sign the contract and return it with your deposit check, money order or by Paypal. At this point this contract will be binding to both parties subject to all above items and conditions. This contract shall not be assigned or transferred by mare owner.
12. All checks should be made payable to Diane Mc Cormick.
13. Majestic Andalusians DM breeding season starts on February 15th and ends on August 1st. Mares not conceiving by August 1st may return the following year unless other arrangements have been made.
14. Stud Fees paid for Costalero XV are NON RETURNABLE under any circumstances. Please be aware of this before signing the contract!
15. Semen will not be shipped to mares under the age of 3 yrs unless it is for the use of Embryo transfer.
16. Owner of stallion has every right to refuse to sell semen to any mare or mare owner.
